# VIII. The GE proposal to the Senate: Sarah Skripsky's suggestions

The committee considered Sarah Skripsky's suggestions. The discussion resulted in updating the wording of the GE proposal, changing "relevant expertise" to "relevant experience." The group collaborated concerning suggested language for the presentation of the proposal to the Senate. It was noted that the change from "i.e." to "e.g." will make the course approval process more equitable while removing rigidity such that courses from a wider range of departments might be considered. Appropriate faculty members will continue to be consulted and the process of decision-making will remain unchanged.

# IX. Working Artistically update: Felicia Song

All relevant departments and instructors reviewed and assessed selected courses per a common rubric with the outcome that the current wording of the certification criteria of the Working Artistically GE is sufficient and requires no updated language. Felicia Song mentioned that a reminder will be sent in January 2023 to add updated syllabit to the website, as needed.
